I. Call to order

President Mikel Knepley called to order the regular meeting of the Town of Greensboro at 6:29PM on May 10, 2021, at Greensboro Community Building.

III. Approval of minutes from last meeting

Minutes from the April meeting were read and same were approved by the board.

IV. Open issues

- a) Reset the town boundaries. Discuss at the August meeting. Ms. Ripberger is looking into matter. UPDATE: Ms. Ripberger will continue to reach out to go through maps. Issue closed.
- b) Paving/Patching Roads: Greensboro was awarded grant. Clerk-Treasurer is reviewing the contract for signature. Kylie Hilton and Alley Gary will work together as a sub-committee to work on fundraising. Garage sale/bake sale is Saturday May 15th beginning at 7:00 AM 5:00 PM. Get a booth at Freedom Days and do a 50/50 drawing.
- c) Greensboro Solar Panel Project: Still pending
- d) Kenny Hunter's Alley. Some gravel has been dumped, but we need to reach out to IMI or Hollinger's to see where he gets his gravel.
- e) Johnny Hall's dog – reign in the new dog. Appears the other dog has been relocated. Issue written violation. Perhaps reach out to animal control to see what they say regarding coming out.
- f) Women's bathroom, middle stall, water leakage. Mike to fix. Purchase a new toilet.


- g) DAR Flag and Tree Donation. Tree has been planted. We still need a wall mount for the flag.
- h) Bylaws. Searched recorder's office records on Doxpop. No results of bylaws. Revisit working group to create bylaws.
- i) Lights fixed in "office." Was that completed? Issue closed.
- j) Term Limits/Election. The town board's term limits are up in 2023. If anyone wishes to run against a board member, they will need to file their intent with the Voter Registration office in January of 2023. A vote would then need to be held, which would be done by the Clerk-Treasurer. Issue closed.

V. New business

- a) 2021 Clean Up Your Town – Dumpster is \$220. Board approved. Set at the community building June 14th to June 18th.
- b) Dwayne Estelle – give him a verbal warning about noise complaint about dog.
