### **I. Call to order**

### **IV. Open issues**

1. Paving/Patching Roads: Paving is complete. Grant recertification for North side has been submitted. Town portion approximately \$37,000. Still waiting
2. Police Department update. Month of August: 166 patrol hours, 54 admin hours, 62 traffic stops, 58 warnings, 4 tickets, 65 business checks (churches, community buildings, etc.), 24 training hours.

3. Southside of High Street – possible flaws. Representative from Midwest Paving indicated it was a draining issue and there wasn't much they could do. Matter closed.



5. Clerk-Treasurer. Contact Rayann if you would like to take over. Submitted resignation to Henry County Clerk. Democratic Party is looking for someone to replace.
6. Bush covering stop sign/reduce speed sign. Still needs to be done.
7. Dead End sign at S. High Street and E Main Street. Town will move the dead in sign up higher.
8. Ordinances. Still working on.
9. Alleyway between 150 and 160 is being blocked by vehicles. Officers need a map so that they can enforce the no parking/blocking.
10. Town drain on West Main Street has collapsed. Needs formed up and a grate added up. Possible grant to fix drainage issues.

**V. New business**


1. President made a motion to have the locks changed on the doors. Motion approved 2-0
2. Halloween. Saturday, October 29, 2022, from 5:00PM to 8:00PM


President adjourned the meeting at 7:59PM
